It was a cold winter day when I stumbled upon a curious article detailing the history and challenges faced by online betting platforms operating in Germany. Why were online gambling platforms illegal in Germany until July 2021?

Answer: Online gambling platforms were illegal in Germany until July 2021 because the German government had not yet issued any licenses for these platforms. Bwin was only able to legally offer its services in Germany from July 2022, after obtaining a license.

Why were Bwin's sports betting and casino offers illegal in Germany for years?

Answer: Bwin's sports betting and casino offers were illegal in Germany for years because the company did not have a license to operate these services. Bwin, Premium and Sportingbet only received their licenses for sports betting in October 2020 and for casino games in November 2022.

Answer: Several other betting providers in Germany, such as Tipico, Betano, and Bet-at-home, were illegal because they did not have the necessary licenses to operate. The German government only started issuing licenses for online sports betting in Germany in October 2020.

When did online sports betting become legal in Germany?

Answer: Online sports betting became legal in Germany in July 2021, when the German government started issuing licenses for these platforms. Before that, online sports betting were completely banned in Germany since 2008.
