Alejandro Zverev llega a un acuerdo para resolver el caso de agresión

The German tennis star Alexander Zverev and his ex-girlfriend have reached an agreement to resolve the case of aggression, without recognition of guilt on the part of Zverev, announced the District Court of Tiergarten in Berlin in a statement on Friday.

Zverev was accused of "physical abuse and damage to the health of a woman during a discussion in Berlin in May 2024", according to a declaration of the court on October 31, 2024.

The 27-year-old player was accused of "strangling briefly his then-girlfriend in the neck with both hands in the hallway of an apartment building in Berlin during a discussion", according to judicial documents. The victim reportedly had difficulty breathing and considerable pain, according to the court's statement.

Zverev received a fine order and was fined with €450,000 (R\$478,000) on October 2, 2024. He denies the accusations and has filed an appeal.

The trial began on May 31 and was scheduled to continue for several days until July 19, but ended after three days.

"The accused and the co-plaintiff had agreed on the interruption of the proceedings", said the court in its statement on Friday.

Zverev has been ordered by the court to pay a fine of €200,000 (R\$217,846) of which €150,000 (R\$163,381) will go to the state treasury and €50,000 (R\$54,457) will go to the "Fund for Fines in Favor of Beneficial Institutions" administered by the Berlin Court of Appeal.

In a statement on Friday, the tennis player's lawyers said: "Alexander Zverev has agreed to this dismissal through his defense lawyer, solely to shorten the proceedings - above all in the interest of his son."

"Alexander Zverev considers himself innocent. The interruption does not constitute a finding of culpability or an admission of culpability. The legal presumption of innocence remains in place."

He has attempted to communicate with the plaintiff's lawyers to obtain comments.

Zverev is scheduled to play against the Norwegian Casper Ruud in the semifinals of the Abierto de Francia on Friday, with both players seeking their first Grand Slam title.

Purcell jogou nas duplas na abertura de terça-feira contra a França menos que três dias depois da vitória Flushing Meadow, mas estava lutando com o fato do time ter decidido usar borracha no domingo ao lado Matt Ebden enquanto os ex campeões dos Wimbledon foram derrotado.
